

CASA PLAYHOUSE GIVEAWAY 2023

1. Eligibility

The CASA Playhouse Giveaway (the “Giveaway”) is open to legal residents, 18 years or older, of the state of Oklahoma. Delivery of the prize is ONLY available to winners in the following Oklahoma Counties: Carter, Love, Johnston, Marshall, and Murray. If a winner lives in a county outside the five county area, they will be responsible for pick-up and delivery.

Winner may choose to donate the winnings to a local foster family of sponsors choosing.

Employees of CASA of Southern Oklahoma and other companies associated with the promotion of the Giveaway, and their respective parents, subsidiaries, affiliates and advertising and promotion agencies as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Giveaway is subject to federal, state, and local laws and regulations.

2. Sponsors

3. Agreement to Official Rules

Participation in The Giveaway constitutes entrant’s full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsors, which are final and binding. Winning a prize is contingent upon being compliant with the Official Rules and fulfilling all other requirements set forth herein.

4. Giveaway Period

The Giveaway begins on November 1, 2023 at 12:01am and ends on December 13th at 11:59pm (“Giveaway Period”). Entries that are submitted before or after the Giveaway Period will be disqualified.

5. How to Enter

All entries become the property of Sponsors and will not be acknowledged or returned. Submissions will be accepted for the duration of the Giveaway using the following methods.

- Each entry will be assigned a “ticket number”. If you would like to know your ticket number(s), please call 580-226-0009.
- Additional chances may be purchased for the following increments: \$22 for five chances, \$60 for 15 chances, and \$100 for 26 chances.
- Chances will also be given to entries received in the following manner:
 - Mail, with proper postage, a 3x5 index card with your full name, address, phone number (including area code), date of birth, and email address, with the words “I want to win the CASA Playhouse” to CASA Playhouse Giveaway, C/O CASA of Southern Oklahoma, 20 B Street SW, Suite 401, Ardmore, OK, 73401. Mail-in entries must be hand-printed and mailed

separately. All entries must be post-marked by December 12th and received by December 13th at 11:59pm.

6. Prize Drawing

On or about December 14th, CASA of Southern Oklahoma will select a potential winner in a random drawing from among all eligible entries received. The odds of being selected depend on the number of entries received. CASA employee will attempt to notify the potential winner via telephone or email on or about December 14th. If the potential winner cannot be contacted within five (5) days after the date of the first attempt to contact him/her, the Sponsors may select an alternate selected potential winner in his/her place at random from the non-winning eligible entries.

7. Winner Notification

The potential winner will be notified by email, mail or phone. The potential prize winner will be required to complete, electronically sign and submit a Declaration of Compliance within five (5) days of the date notice or attempted notice is sent, in order to claim his/her prize. If a potential winner cannot be contacted, or fails to submit the Declaration of Compliance within the required time period, or prize is not picked up or delivered, potential winner forfeits prize. Potential winners must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. In the event that a potential winner is disqualified for any reason, Sponsors will award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries. Only three (3) alternate drawings will be held, after which the prize will remain un-awarded. Prizes will be fulfilled approximately two (2) to ten (10) days after the conclusion of the Giveaway.

9. General Conditions

The Sponsors reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Giveaway or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner.

10. Release and Limitation of Liability
